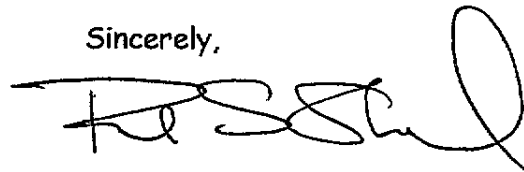

I, the undersigned, hereby submit and file these Articles of Incorporation for the purposes of establishing a corporation for profit under the "Florida Corporation Act".

I.

The name of the corporation is:

This corporation will engage in the business of audio-visual installation for individuals, partnerships, and corporations permitted under the laws of the State of Florida and the United States of America.

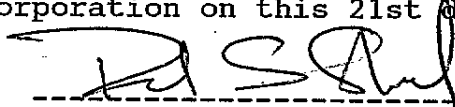
