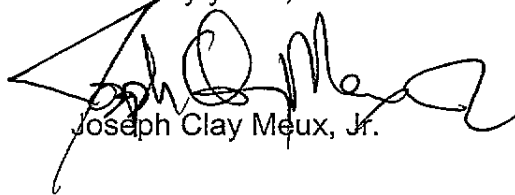

ARTICLES OF INCORPORATION
OF
ANDREW L. SKIGEN, D.M.D., P.A.

I, the undersigned incorporator to these Articles of Incorporation, being a natural person competent to contract and a dentist duly licensed to render professional service as such in the State of Florida, do hereby form a professional corporation under the laws of the State of Florida pursuant to the provisions of Chapters 607 and 621, Florida Statutes.

Article I - Name

The name of this corporation is **ANDREW L. SKIGEN, D.M.D., P.A.**

Article II - Duration

This corporation shall have perpetual existence.

Article III - Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

Article IV - Capital Shares

This corporation is authorized to issue a single class of common stock in an aggregate number of 1,000 shares, having \$1.00 value per share, each share carrying the right of one vote.

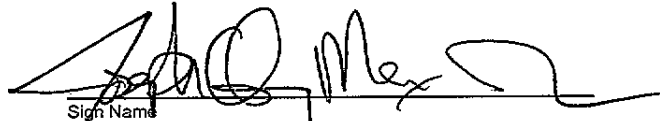
