ARTICLES OF INCORPORATION OF UNLEARNED, INC.



The undersigned subscriber, CHARLES CONRAD, JR., a natural person competent and acting as Incorporator for the purpose of forming a Not For Profit Corporation, hereby presents these Articles of Incorporation for the formation of a corporation under the Florida Not For Profit Corporation Act, chapter 617 of the Florida Statutes, and other laws of the State of Florida.

ARTICLE I

NAME, PRINCIPAL OFFICE AND MAILING ADDRESS

The name of the Not for Profit Corporation is Unlearned, Inc.

ARTICLE II

PURPOSE

The general nature of the business to be transacted, and the purposes for which the Not for Profit corporation is organized, are:

A. To provide opportunities intended to open channels of dialog to build understanding and loving relationships between Christians and non Christians within their communities.

Fellowship opportunities shall be established in non-threatening environments using improvisational comedy programs, including individuals and groups.

Ministry consulting opportunities shall be established through the conducting of clinics and workshops with groups and individuals interested in providing similar non threatening venues in their communities on a regular basis.

The foregoing paragraphs shall be construed as enumerating both objects and purposes of the not for profit corporation, and it is expressly provided hereby that the foregoing enumeration of specific purposes shall not be held to limit or restrict in any manner the purposes of the not for profit corporation otherwise permitted by law.

ARTICLE III DURATION AND COMMENCEMENT

The not for profit corporation shall commence existence on February 7, 2000 and shall have perpetual existence.

ARTICLE IV
