ARTICLES OF INCORPORATION

ARTICLE 1. NAME. The name of the corporation shall be JJW.
H, INC. 222 S. NEW YORK AVE WINTER PARK, FL 32789

ARTICLE 11. DURATION. The corporation shall exist
perpetually.

ARTICLE 111. PURPOSE. The purpose of this corporation is to
consult to and manage other businesses and for the purpose of the
transaction of any other lawful business for which corporations may be
incorporated under the laws of the State of Florida.

ARTICLE 1V. CAPITAL STOCK. This corporation is authorized

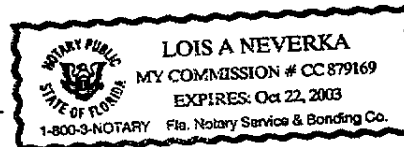

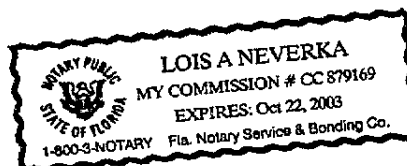
