

**ARTICLES OF INCORPORATION**

SUPERIOR LAWN SERVICE OF CITRUS COUNTY, INC.

The undersigned incorporator, being a person competent to contract, subscribe to these Articles of Incorporation to form a corporation for profit under the laws of the state of Florida.

**ARTICLE I - NAME**

The name of the corporation shall be:

SUPERIOR LAWN SERVICE OF CITRUS COUNTY, INC.

**ARTICLE II - BUSINESS AND ACTIVITIES**

The corporation may engage in any activity or business permitted under the laws of the United States, and of the State of Florida.

**ARTICLE III - CAPITAL STOCK**

A. The authorized capital stock of this corporation and the maximum number of shares of stock that this corporation is authorized to issue and have outstanding at any time is 1,000 shares of common stock having a par value of \$1.00 per share.

B. All or any portion of the capital stock may be issued in payment for real or personal property, services, or any other right or thing having a value in the judgment of the Board of Directors, at least equivalent to the full value of the stock so to be issued as hereinabove set forth, and when so issued, shall become and be fully paid and non assessable, the same as though paid for in cash, and the Directors shall be the sole judges of the value of any property, right or thing acquired in exchange for capital stock and their judgment of such value shall be conclusive.

**ARTICLE IV - TERM OF EXISTENCE**

This corporation shall have perpetual existence beginning on FEBRUARY 1, 2000 and shall exist thereafter unless dissolved according to law.

**ARTICLE V - PRINCIPAL OFFICE**

The principal office of the corporation shall be located at :

**ARTICLE VII -DIRECTORS**

These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the Board of Directors, proposed by them to the Shareholders, and approved at a shareholders meeting by the holders of a majority of the stock issued and entitled to be voted, unless all the Directors and all the Shareholders sign a written statement manifesting their intention that a certain amendment to these Articles of Incorporation be made.

### ARTICLE X - BY-LAWS

The power to adopt, alter, amend or repeal by-laws of this corporation shall be vested in the Shareholders or the Board of Directors of this corporation provided, however, that any by laws adopted by the Directors which are inconsistent with any by-laws adopted by the Shareholders shall be void, and the Directors may not alter, amend or repeal any by-laws adopted by the Shareholders.

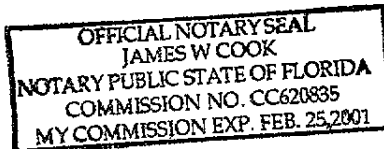


