ARTICLES OF INCORPORATION

SUNFLOWER INK, INC.

The undersigned, for the purpose of forming a corporation for profit under the Florida General Corporation Act, do hereby adopt the following articles of incorporation.

ARTICLE I

SUNFLOWER INK, INC.

The name of the corporation shall be: SUNFLOWER INK, INC.

ARTICLE II

DURATION

The corporation shall have perpetual existence with an effective commencement date of FEBRUARY 15, 2000.

ARTICLE III

PURPOSE

The general purposes for which the corporation is organized are:

1. To engage in the business of Commissioned Sales.
2. To transact any other lawful business activity for which corporations may be incorporated under the Florida General Corporation Act.

ARTICLE IV

REGISTERED OFFICE AND REGISTERED AGENT

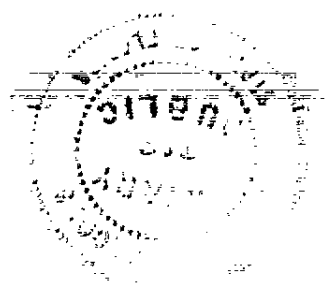
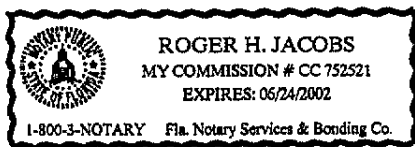
