ARTICLES OF INCORPORATION OF DEVI KRUPA, INC.

The undersigned, desiring to form a corporation under the Florida General Corporation Act, makes and subscribed to the following Articles of incorporation.

ARTICLE I

The name of this corporation is **DEVI KRUPA, INC.**

ARTICLE II DURATION

This corporation shall have perpetual existence.

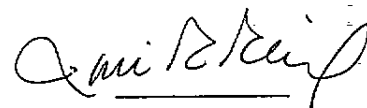

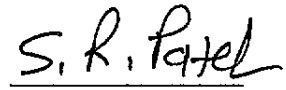
