ARTICLES OF INCORPORATION

EURENA'S FASHIONS OF MIAMI, INC. A FLORIDA FOR-PROFIT CORPORATION



The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, as amended, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I: NAME OF THE CORPORATION

The name of the Corporation shall be: EURENA'S FASHIONS OF MIAMI, INC., hereinafter referred to as the "Corporation".

ARTICLE IL: PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the principal office and the mailing address of the Corporation is P.O. Hor 370-866, Mizmi, Florida 33137.

ARTICLE III. DURATION OF THE CORPORATION

The period of duration of the Corporation shall be perpetual unless dissolved according to law.

ARTICLE IV: PURPOSE OF THE CORPORATION

ARTICLE V: AUTHORIZED SHARES

The Board of Directors may authorize the issuance of such stock to such person(s), upon such terms, and for such consideration as they may deem appropriate. ARTICLE VI: PREEMPTIVE RIGHTS

The Corporation elects to have preemptive rights. Every shareholder, upon sale for cash of any new or reissued stock of the Corporation, shall have the right to purchase his or her pro-miz share thereof at the price at which it is offered to others.

ARTICLE VII: INITIAL REGISTERED OFFICE AND AGENT

ARTICLE XI: PRE-INCORPORATION LIABILITY


