# **ARTICLES OF INCORPORATION**

# OF Mr. Hook Towing, Inc.



I, the undersigned, being of legal age and a natural person, do hereby subscribe to, acknowledge and file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

## ARTICLE I

The name of this corporation shall be **Mr. Hook Towing**, **Inc.** and the initial address of this corporation shall be **217 N.W. 101st Avenue**, **Plantation**, **Florida 33324**.

# **ARTICLE II**

This corporation may engage in any activity or business permitted under the laws of the State of Florida.

#### ARTICLE III

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:
