ARTICLES OF INCORPORATION OF BRICK LAND, INC.

The undersigned, for the purposes of forming a corporation for profit pursuant to the Laws of the State of Florida, does hereby adopt the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation is: BRICK LAND, INC.
