ARTICLES OF INCORPORATION

OF

The undersigned incorporator, who is licensed as an attorney in the State of Florida, does hereby make, subscribe, file and acknowledge these Articles of Incorporation for the purpose of organizing a professional service corporation under Chapters 607 and 621 of the Florida Statutes.

ARTICLE I.

The name of the corporation is KURT S. HARMON, P.A.

ARTICLE II.

The duration of the corporation is perpetual.

ARTICLE III.

The purposes for which the corporation is organized are to engage in and carry on the practice of law and to do those things necessary or proper in connection with that practice, with all powers conferred on professional service corporations by the laws of the State of Florida.
