During a review of SHRI, Inc.'s records, it was determined that the 2002 For Profit Uniform Business Report (UBR) had not been received, either at the place of business or at my home.

A phone call to your office in Tallahassee brought about the unpleasant fact that the corporation was dissolved on 9/21/2001 because of non-receipt of the annual report. According to the phone call, this report was sent to 436 Summerlin Avenue, Orlando, FL, which is the address of my former partner, George Kalajian, who has since moved out of state. I do not know his forwarding address.

I have never been in receipt of the application for 2001, and now I know why I have not received the UBR for 2002.

As told on the phone on 1 February, I could rectify this problem by sending this letter of explanation, the forms for each year and \$150.00 for each year and would not have to pay any late charges because of the non receipt of the UBR. I am sending two completed forms (one each for year 2001 and 2002); 2 company checks payable to Department of State (one for \$158.75--\$150.00 for 2001 and \$8.75 for a Certificate of Status; one for \$150.00 for 2002) as stipulated by the instructions. I am also submitting a copy of the legal document that shows I am the sole partner/owner of the corporation.
