ARTICLE I - NAME

The name of the Corporation is RHODES BUILDING & REMODELING CORPORATION

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The Purpose of this Corporation is to engage in any activities or business permitted under the Laws of the United States and Florida.

ARTICLES IV - CAPITAL STOCK

The maximum number of shares which this Corporation is authorized to have outstanding at any time is 1000 shares of common stock having a par value of \$ 1.00 per share.

ARTICLE V - PRINCIPLE OFFICE

The holders of the common stock of this corporation shall have preemptive rights to purchase, at price, terms and conditions that shall be fixed by the Board of Directors, those shares if the common stock of this corporation which may be issued from time to time for money, property or past services in addition to that stock authorized and issued by the corporation. The preemptive right of any holder is determined by the ratio of the authorized and issue shares of common stock held by the holder and all shares of common stock currently authorized and issued.
