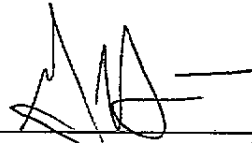

The effective date of the adoption by the Directors, Shareholders and Officers of the above mentioned Amendments was November 28, 2000.

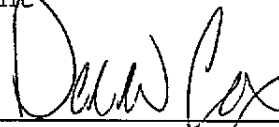
