THE UNDERSIGNED, for the purposes of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation.

ARTICLE ONE: The name of the corporation is DHM LANGUAGE SCHOOL, INC.

ARTICLE TWO: The duration of the corporation is perpetual.


