I

The name of the proposed corporation is:

The Corporation may engage in any activity or business permitted under the laws of the United States, and of the State of Florida.

XIII

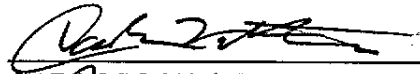
