ECRETARY PAIS: 10 The undersigned, for the purpose of forming a corporation for profit under the laws o Florida, adopts the following Articles of Incorporation:

> Article I Name



Section 1.1. Name. The name of this corporation shall be L'Orient, Inc.

Article II Principal Office and Mailing Address

Section 2.1, Principal Office and Mailing Address. The principal place of business and mailing address of this corporation shall be 1540 Atlantic Boulevard, Jacksonville, Florida 32207.

Article III Capital Stock
