# ARTICLES OF INCORPORATION OF

GOTTAGO OF PUTNAM COUNTY INC.

In compliance with the requirements of Florida Statutes, Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

## ARTICLE I

The name of the corporation ("Corporation") is Gottago of Putnam County Inc.

## ARTICLE II

Existence of the corporation will begin when the Articles of Incorporation have been filed.

## ARTICLE III

The maximum number of shares this Corporation is authorized to issue is one hundred shares (100), all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share upon all matters on which shareholders have the right to vote.

## ARTICLE IV

The principal place of business and mailing address of the Corporation is 122 Penial Store Road - Rt. 3 Box 2411, Palatka, Florida, 32177. ## ARTICLE VI

The name and address of the person signing these Articles of Incorporation is Charles Smith whose address is 122 Penial Store Road, Palatka, Florida, 32177.


## ARTICLE VII

## ARTICLE VIII


The corporation through its directors and shareholders reserve the right to file a Subchapter S election with the Internal Revenue Service.
