**ARTICLE I  
NAME**

The name of this corporation shall be:

J.R. BEHAVIORAL SERVICES, INC.

**ARTICLE II  
DURATION**

This corporation shall commence its existence upon the filing of these Articles and the duration of this corporation is perpetual.

PURPOSE**
