Name

1.1. The name of the corporation is Copies Today, Inc. and the corporation's business address is 2151 West Bush Blvd., Tampa, Florida 33612.

ARTICLE II

Duration

2.1 This corporation shall have perpetual existence commencing on the date of filing of these Articles of Incorporation with the Department of State of Florida.

ARTICLE III

Purpose

Indemnification

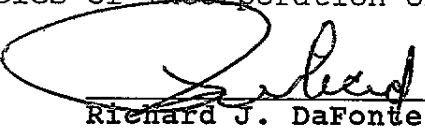

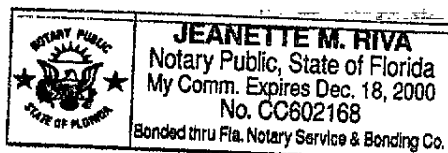
