**ARTICLES OF AMENDMENT TO  
THE ARTICLES OF INCORPORATION  
OF ORLANDO FABRICATION & FIRE- OUT SYSTEMS, INC.**

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned Florida corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

Article I - Name

The name of the corporation is ORLANDO FABRICATION & FIRE- OUT SYSTEMS, INC. (hereinafter referred to as the "Corporation").

Article II - Adoption and Text of Amendments

All of the directors of the Corporation approved a resolution amending Article 1 of the Articles of Incorporation by written consent dated June 22, 2000 in accordance with the provisions of Section 607.0821 of the Florida Statutes, and all of the shareholders of the Corporation approved the resolution amending Article 1 of the Articles of Incorporation by written consent dated June 22, 2000, in accordance with the provisions of Section 607.0704 of the Florida Statutes. RESOLVED, that Article 1 of the Articles of Incorporation of the Corporation be amended in its entirety to read as follows:

"ARTICLE 1 - Name. The name of this Corporation shall be VICTOR INDUSTRIES INTERNATIONAL, INC."
