**ARTICLES OF AMENDMENT TO  
THE ARTICLES OF INCORPORATION  
OF VICTOR INDUSTRIES INTERNATIONAL, INC.**

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned Florida corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

Article I - Name

The name of the corporation is VICTOR INDUSTRIES INTERNATIONAL, INC. (hereinafter referred to as the "Corporation"). Its Florida document number is P00000015655.

Article II - Adoption and Text of Amendments

The Board of Directors of the Corporation approved a resolution amending Article IV of the Articles of Incorporation by written consent dated January 31, 2022, in accordance with the provisions of Section 607.0821 of the Florida Statutes, and the number of votes cast for the amendment was sufficient for approval. Additionally, the shareholders of the Corporation approved a resolution amending Article VII of the Articles of Incorporation by written consent dated January 31, 2022, in accordance with the provisions of Section 607.0704 of the Florida Statutes, and the number of votes cast for the amendment was sufficient for approval. The following is a true and correct copy of the resolutions amending Article IV of the Articles of Incorporation:

RESOLVED, that Article IV of the Articles of Incorporation of the Corporation is amended in its entirety to read as follows:

Article IV - CAPITAL STOCK


The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is ten thousand shares (10,000), having a par value of One Dollar (\$1.00) per share.
