The undersigned, acting as Incorporator of a Florida corporation under the Florida General Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such Corporation:

#### ARTICLE I

# **NAME**

The name of the Corporation is <u>ALL SEASONS NURSERY, INC.</u> The mailing address for the principal office of this corporation is 5538-A N.W. 43<sup>rd</sup> Street, Gainesville, Florida 32653.

#### ARTICLE II

#### **DURATION**

The Corporation shall have perpetual existence, and shall be in existence upon signing these Articles or later if required by law.

#### ARTICLE III

# **PURPOSE**

The Corporation is organized for any lawful purpose permissible under the laws of the State of Florida and under the laws of the United States of America.


