ARTICLES OF INCORPORATION
OF
WCM SERVICES, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, does hereby sign and direct these Articles to be delivered to the Department of State, State of Florida, for the purpose of forming a corporation under the laws of the State of Florida.

Article 1 - Name and Mailing Address

The name of this corporation is WCM SERVICES, INC. and its mailing address shall be Post Office Box 511171, Punta Gorda, Florida 33951.

Article 2 - Duration of Corporate Existence

The effective date of this corporation shall be the date of filing of these Articles of Incorporation. This corporation shall exist perpetually.

Article 3 - Purposes

The general purposes for which this corporation is organized include the transaction of any or all lawful business for which corporations may be incorporated under the provisions of Chapter 607, Florida Statutes, as the same now exists or as it may hereafter be changed.

Article 4 - Capital Stock

The aggregate number of shares of stock this corporation is authorized to have outstanding at any time is One Hundred (100) shares of common stock. There shall be no other type or class of stock.

Article 5 - Address and Registered Agent

The street address of the initial registered office of this corporation shall be 4087 Cape Cole Boulevard, Punta Gorda, Florida 33955. The name of the initial registered agent at such address is William C. Mintzer.

Article 6 - Directors

This corporation shall have one (1) director initially. The number of directors may be increased or decreased from time to time by the By-Laws adopted by the shareholders, but shall never be less than one (1) nor more than five (5).

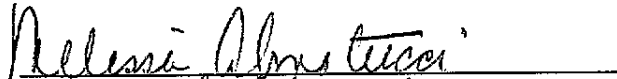

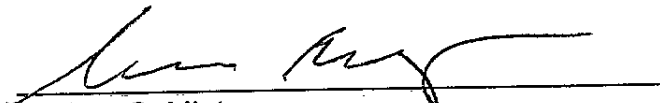
