**Article I  
Name**

The name of the professional corporation is LAW OFFICES OF JOSEPH R. ROWE JR.

**Duration**

This professional corporation shall have a perpetual existence.

##### **Powers**

This corporation shall have all the corporate powers enumerated in the Florida Business Corporation Act and the Professional Service Corporation and Limited Liability Act.

#### **Article X**

##### **Indemnification**

Such indemnification shall continue as to a person who has ceased to be a director, officer, employee or agent, and shall inure to the benefit of the heirs and personal representatives of such person. An adjudication of liability shall not affect the right to indemnification for those indemnified.

##### **Amendment**

This professional corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation or any amendment hereto, and any right conferred upon the shareholders is subject to this reservation.

#### **Article XII**

##### **Bylaws**

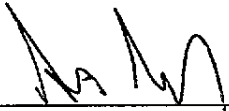
