ARTICLES OF INCORPORATION

OF

Over @ Scott Tz Inc.

BY THESE ARTICLES OF INCORPORATION, the incorporators form a corporation for profit under Florida law.

NAME

The name of this corporation is Over @ Scott Tz Inc.

ADDRESS

The physical location of the corporation shall be at 1393 45th Street,

TERM

This corporation shall exist perpetually.

PURPOSE

The purpose of this corporation is to transact any or all lawful business for which corporations may be incorporated under Florida law.

STOCK

The corporation is authorized to issue 10,000 shares of common stock with a \$1.00 per value. The stockholders may dispose of the authorized and unissued stock from time to time.
