The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

COM.RES LANDSCAPING AND LAWN MAINTENANCE, INC.

ARTICLE II. NATURE OF BUSINESS

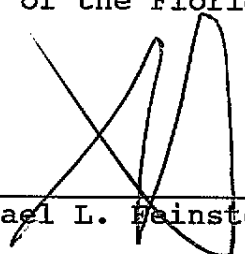
