ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this Corporation is DA UNDERGROUND SOURCE, INC.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing
on FEBRUARY 7, 2000.




