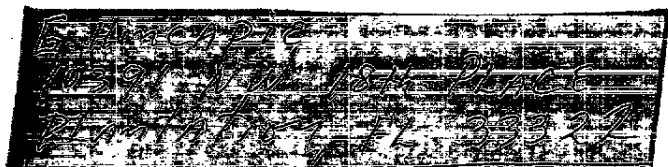

ARTICLE I

NAME: The name of this Corporation is SMALL BUSINESS RESULTS, INC. and its address is 10391 NW 18th Place, Plantation, Florida 33322.

ARTICLE II

DURATION: this Corporation shall have perpetual existence.
