

ARTICLES OF INCORPORATION

OF

PSALMS LANDSCAPE COMPANY INCORPORATED

The undersigned, acting as incorporator of a Corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such Corporation.

ARTICLE 1

The name of the Corporation is:

PSALMS LANDSCAPE COMPANY INCORPORATED

ARTICLE 11

The Corporation shall commence its existence immediately upon the filing of these Articles of Incorporation and shall exist perpetually thereafter unless sooner dissolved according to Law.
