ARTICLES OF INCORPORATION
of
EUSTIS LEASING, INC.

The undersigned natural person, competent to contract, acting as incorporator for the purpose of organizing a corporation pursuant to Florida Statutes Chapter 607, the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

Article I. Name. The name of the corporation is: EUSTIS LEASING, INC.

Article II. Duration; Effective Date. The corporation shall have perpetual existence commencing as of February 7, 2000.

Article III. Purposes. The purposes for which the corporation is organized are: To engage in and do any or all lawful acts or activities and to engage in and transact any or all lawful business permitted under the laws of the United States and the laws of the State of Florida.

Article IV. Authorized Stock. The corporation is authorized to issue One Thousand (1,000) shares of common stock of the par value of One Dollar (\$1.00) a share.

Article V. Initial Registered Office and Agent. The street address of the initial registered office of the corporation is 29605 U.S. 19 N., Suite 330, Clearwater, Florida 33761. The name of the initial registered agent of the corporation at this office is Frank N. Crossland.

Article VI. Initial Board of Directors. The corporation shall have a board of directors which shall initially consist of one (1) individual. The number of directors may be increased or decreased from time to time by an amendment to, or in the manner provided in, the bylaws, provided that the number of directors shall not be less than one (1) individual at any time. The name and the address of the individual who shall serve as the initial director of the corporation are: Dianna King, 2766 Edenwood St., Clearwater, Florida 33759.

Article VII. Incorporator. The name and the address of the incorporator are: Frank N. Crossland, 29605 U.S. 19 N., Suite 330, Clearwater, Florida 33761.

Article VIII. Principal Office and Mailing Address. The initial principal office address of the corporation is: 415 N. Grove St., Eustis, Florida 32726. The initial mailing address of the corporation is: 20520 E. Pennsylvania Ave., Dunnellon, Florida 34432. The corporation reserves the privilege of having branch or other offices at places within or outside the State of Florida.

Article IX. Powers. The corporation shall have all of the corporate powers enumerated in Chapter 607, Florida Statutes, as amended from time to time.

Article X. Amendment of Articles. The corporation reserves the right to amend, alter, change, or repeal any provision or provisions contained in these Articles of Incorporation, or any amendment thereto, in accordance with the laws of the State of Florida as amended from time to time.




