The undersigned incorporator, MELISSA E. JOHNSON, a natural person competent to contract, and with the consent of the sole officer, director and owner of the corporation created hereunder, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

ARTICLE I - NAME

The name of this corporation is **ELIZABETH J. DAVIS, INC.**, a Florida corporation.

ARTICLE II - PRINCIPAL OFFICE

The address of the principal office of the corporation is 4444 W. Highway 30-A, Santa Rosa Beach, Florida, Florida 32459.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business under the laws of the State of Florida and the laws of the United States.

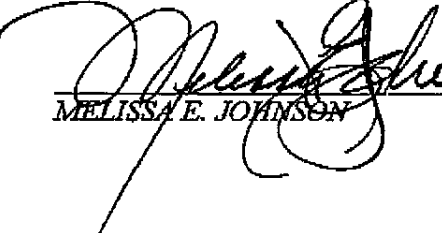
