

**ARTICLES OF INCORPORATION**  
**OF**  
**TAYLOR LAWN & LANDSCAPING SERVICES, INC.**

*The undersigned incorporator(s), being an individual duly licensed to render lawn care and landscaping services, hereby form a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.*

**ARTICLE I. CORPORATE NAME.**

*The name of the corporation shall be: Taylor Lawn & Landscaping Services, Inc.*

**ARTICLE II. NATURE OF BUSINESS AND POWERS.**

*The general nature of the business to be transacted by this Corporation is to:*

- 2. Transact any or all lawful business for which corporations may be incorporated under the Florida Business Corporation act, and as permitted under the laws of the State of Florida.*
- 3. Do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.*


