ARTICLE I. - NAME

The name of the corporation is BDR Management, Inc.



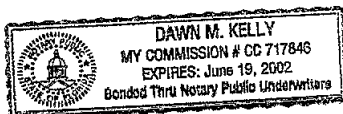


