ARTICLE I - NAME

The name of this Corporation is PROSPERITY MAINTENANCE CORPORATION.

ARTICLE II - SUB CHAPTER S ELECTION

ARTICLE VI - PREEMPTIVE RIGHTS





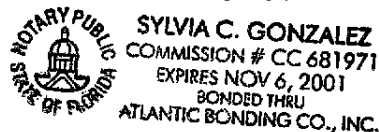
