ENTRY FORM, INC.**

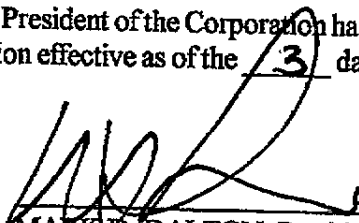
1. Article "I" of the Articles of Incorporation of **ENTRY FORM, INC.** is hereby amended as follows:
