ARTICLES OF INCORPORATION
OF
FROM ME TO YOU CONSIGNMENTS, INC.

The undersigned, acting as Incorporators to these Articles of Incorporation, of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation.

ARTICLE I
NAME

The name of the corporation is **FROM ME TO YOU CONSIGNMENTS, INC.**

ARTICLE II
PURPOSE

To engage in the business of receiving consigned goods from the owner thereof and reselling said goods to third parties for a commission.

To take, buy, exchange, lease or otherwise acquire real property and any interest or right therein, and to hold, own, operate, control, maintain, manage, and develop such property and interests in any manner that may be necessary, useful or advantageous for the purpose of this corporation.

To carry on any business whatsoever that this corporation may deem proper or convenient in connection with any of the foregoing purposes or otherwise, or that it may deem calculated, directly or indirectly, to improve the interest of this corporation, and to have and to exercise all powers conferred by the laws of the State of Florida on corporations formed under the laws pursuant to which and under which this corporation is formed, as such laws are now in effect or may at any time hereafter be amended, and to do any and all things hereinabove set forth to the same extent and as full as natural persons, firms, associations, or corporations, and in any part of the word.

The foregoing statement of purposes shall be construed as statement of both purposes and powers, shall be liberally construed in aid of powers of this corporation, and the powers and purposes stated in each clause shall, except where otherwise stated, be in no wise limited or restricted by any term or provision of any other clause, and shall be regarded not only as independent purposes, but the purposes and powers stated shall be construed distributively as each object expressed, and the enumeration as to specific powers shall not be construed as to limit in any manner the aforesaid general powers, but are in furtherance of, and in addition to and not

limitation of said general powers.

ARTICLE III.
CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is One Thousand (1,000) shares of common stock, each share having a par value of One (\$1.00) Dollar. Said authorized shares shall be voting shares.

Authorized capital stock may be paid for in cash, services or property at a just value to be fixed by the Board of Directors of this corporation at any regular or special meeting.

ARTICLE IV.
INITIAL CAPITAL

The amount of capital with which this corporation shall begin business is One Thousand and NO/100 Dollars (\$1,000.00).

ARTICLE V.
TERMS OF EXISTENCE

This corporation shall have perpetual existence.

ARTICLE VI.
PRINCIPAL PLACE OF BUSINESS

The initial street address of the principal place of business of this corporation is 124 E. Main Street, Wauchula, FL 33873. The Board of Directors from time to time may designate such other address and place for the principal office of this corporation as it may seem fit.

ARTICLE VII.
REGISTERED AGENT

Pursuant to Chapter 48.091, Florida Statutes, the following is submitted in compliance with said Act:

That **FROM ME TO YOU CONSIGNMENTS, INC.**, desiring to organize under the laws of the State of Florida, with its principal office in the City of Wauchula, County of Hardee, has named **SHARON SUE NEAL**, located at 931 Cecil Durrance Road, Wauchula, FL 33873, as its agent to accept service of process within the State.

ARTICLE VIII
DIRECTORS

The corporation shall have two (2) directors initially. The number of directors may be increased or diminished from time to time by the By-Laws of the corporation, but shall never be less than one (1).

ARTICLE IX.
INITIAL DIRECTORS

The name and street address of the Initial Directors, who shall hold office until his/her successor(s) are elected and have qualified, is as follows:


