**ARTICLES OF INCORPORATION
OF
PETITT INVESTMENT CORPORATION**

THE UNDERSIGNED, acting as sole incorporator of **Petitt Investment Corporation** (hereinafter, the "Corporation") under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, as hereafter amended and modified (the "FBCA"), hereby adopts the following Articles of Incorporation (the "Articles") for the Corporation:

ARTICLE I
