ARTICLE I
NAME

The name of this corporation shall be:

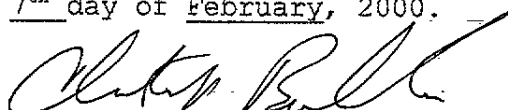
BY-LAWS

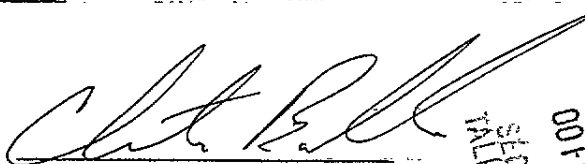
