The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of this Corporation is COSTON WARD & ASSOCIATES, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:  
27232 Big Sur Drive, Wesley Chapel, Florida 33543.

ARTICLE III - SHARES

The maximum number of shares which this Corporation is authorized to have outstanding at any time is 2,000 shares of common stock having a par value of \$1.00 per share. These shares shall have unlimited voting rights that together are entitled to receive net assets of the corporation upon dissolution. The board of directors may determine, in whole or part, the preference, limitations, and relative rights of any class before the issuance of any shares of that class.

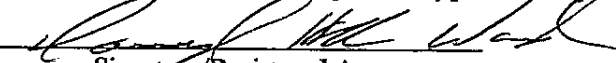
