

ARTICLES OF INCORPORATION

OFER IN THE STATE OF THE STATE The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICL<u>E I. NAME</u>

The name of the corporation shall be:

ARTICLE II EXISTENCE OF CORPORATION

This Corporation shall have perpetual duration unless sooner dissolved according to law.
