ARTICLE I - NAME

The name of the corporation formed pursuant to these Articles of Incorporation is A-Nu-U of Central Florida, Inc.

Every shareholder of the corporation shall have pre-emptive rights as provided in Section 607.0630 of the *Florida Statutes*.


ARTICLE X - INDEMNIFICATION




