

I, the undersigned, hereby request for the purpose of becoming a corporation under and by virtue of the Laws of the State of Florida, by and under the provisions of the Statutes of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation for profit.

ARTICLE I

The name of this corporation shall be:

LANE'S AUTO REPAIR, INC.

### ARTICLE II

The object and purpose of this corporation and the general nature of the business or businesses to be transacted shall be as follows:

- 1. To conduct a Auto Repair business and any and all other businesses as necessary to properly accomplish this purpose.

- 3. To make and enter into all contracts necessary and proper for the conduct of its business or businesses.
- 4. To borrow money of any person, firm or corporation, to issue bonds, debentures or obligations of this corporation from time to time for any objects or purposes of the corporation and to secure same by mortgage, pledge or by any other lawful means.
