#### Article 1. Name

The name of the Corporation is:

Green Acres USA, Inc.

#### Article 2. Duration

The duration of the Corporation is perpetual.

#### Article 3. Purposes

The general purposes for which the Corporation is organized are the following:

- (A) To engage in and transact any lawful business for which corporations may be incorporated under the Florida Business Corporation Act; and


## Article 10. Commencement of Existence
