I have been very conscientious about filing all my returns on time and I have been made aware that due to this error, my corporation may be accessed an additional \$400 for the delay, which must have been caused by the U.S. Postal System.

Based on these circumstances, I would appreciate receiving leniency on the assessment of the \$400 penalty. I have enclosed an updated report and the necessary \$150 filing fee with an additional \$8.75 for an updated certificate.
