The undersigned subscribers to these Articles of Amendment, natural persons, competent to contract, and being the sole and only shareholder of INTELLIMATICS INTERNATIONAL INCORPORATED, hereby execute these Articles of Amendment for the purpose of changing the Articles of Incorporation of the corporation, pursuant to Section 607.1006, Florida Statutes.

ARTICLE I

Article III of the Articles of Incorporation is hereby amended to read as follows: the maximum number of shares of stock this corporation is to have outstanding at any time is 10,000 shares of common stock with a nominal or par value of ONE AND NO/100 (\$1.00) per share.

ARTICLE III

These Articles of Amendment were approved by all shareholders of said corporation, (therefore being unanimous) in a duly called meeting on March 6, 2001. This corporation has fewer than 35 shareholders (it has only two) and therefore, pursuant to Section 607.1003(6), Florida Statutes, the Articles of Incorporation may be amended by the shareholders, without an act of the directors.

ARTICLE IV

Article IV relating to preemptive rights of shareholders is hereby deleted and removed from the Articles of Incorporation.
