ARTICLE I - NAME

The name of this Corporation is TECHNOCABLE WIRING SPECIALIST, INC.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing on FEBRUARY 9, 2000.

price at which it is offered to others.






