

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I. NAME

The name of the Corporation ("Corporation") is

ARTICLE II. TERM OF EXISTENCE

The Corporation is to exist perpetually.

ARTICLE III. ADDRESS

The street address of the principal office of the Corporation is 346 North Volusia Avenue, Orange City, Florida 32763.

ARTICLE IV. CAPITAL STOCK

The maximum number of shares this Corporation is authorized to issue is Ten thousand (10,000) no par value, all of which shall be Common Shares.
