

ARTICLES OF INCORPORATION



READYCERTGO.COM, INC.



The undersigned subscriber of these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. - NAME

The name of the corporation shall be READCERTGO.COM, INC.

ARTICLE II. - PRINCIPAL PLACE OF BUSINESS

The principal place of business shall be 2265 Lee Rd., Suite 200, Winter Park, Florida 32789

ARTICLE III. – AUTHORIZED SHARES OF STOCK

This corporation is authorized to issue One Thousand (1000) shares of \$1.00 par value common stock.

ARTICLE IV. - VOTING RIGHTS

Except as otherwise provided by law, the entire voting power for the election of directors and for all other purposes shall be vested exclusively in the holders of the issued and outstanding common stock of the corporation.
