

The undersigned incorporator James E. Maddox, hereby forms SATURDAY DANCE AND SOCIAL CLUB, INC., a corporation for profit under the Florida General Corporation Act and other laws of the State of Florida.

1. NAME OF CORPORATION AND INITIAL ADDRESS: The name of this corporation shall be SATURDAY DANCE AND SOCIAL CLUB, INC. and its address is 1204C West 19th Street, Panama City, Florida 32405.

2. TERMS OF EXISTENCE: This corporation shall exist perpetually unless dissolved according to law.

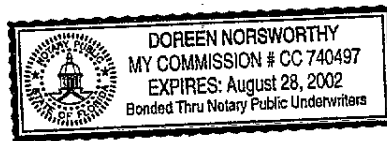


